The following points are put by a member shri B N Venkataraman before the AGM of Shri Ayyappa Sewa Samithi on 9.8.2015 in continuation to his efforts to comment on the working of the teams under the chairmanship of Shri S G Swaminathan like past few AGMs

- 1. The Samithi is not honouring ROS (registrar of society) obligations contravening provision of Societies Registration $Act\ u/s\ 4$ which is a punishable offence.
- 2. The AGMs are conducted for the past six years in blatant violation of our bye laws u/c 13(a), 14,14c, 17, 18
- 3. No proceeding/minutes complete with deliberations were in black and white hard copy of accounts statements not circulated to each member under clause 14a.
- 4. Statutory documents are either not maintained nor available to members for inspection. Also there is a loss of important IT excemption certificate issued u/s 12A, nor any proper attempt to obtain a copy of it.
- 5. The Samithi has its own power to condone the errors and ommissions of the office bearers and relect them. But the Samithi has not exercised its self corrective mechanism.
- 6. The membership list without a proper record maintained by secretary is having a quite number of improper addresses, in just years back letters addressed to as many as 27 addresses had been returned undelivered by courier. To name a few the prominent errors are of VIP's of our Samithi as follows:
 - 1. Shri Ramesh Kurup, former secretary and former registered office address¹
 - 2. Shri K D N Sharma former vice president and held recent post as treasurer2
 - 3. Shri R K Nair, (Sitapur Road Yojna), a bhajan contributor³
 - 4. Shri H Venkataraman, owner of first registered office premises at the time of registration⁴
 - 5. Shri T R G Nair, whom a number of committee members are frequently meeting him almost daily in Ayyappa mandir, Gomti Nagar.⁵

Most of above cases are due to misspelt address which seems to be deliberate. The above are the examples of incorrectnes of the members who are meeting in AGM in spite of wrong address by tele communication etc. But most of errors like this seems to be for the convenience of somebody like prez.

- 7. Election is sought for **five** years without proper amendment of memorandum of association.
- 8. Functioning with invalid registered office address and no correct action taken nor any effort towards this to intimate change of address to ROS under bye-laws 20 and $Act\ u/s\ 4$
- 9. The growth and performance of the samithi was MAXIMUM (in 31 years history) with generating over **58**% of nominal reserve during 2 years of B N Venkataman as secretary that time of the reserves of that time. The performance during the last 5 years is worse with about 2.82 lacs loss which is about **-54.23**% less than normal 10% growth (i.e. Total of -43%) of our nominal reserve, during the periods of Shri S G Swaminathan as president and with master minding of vice president. That is very high under-performance in years from 2010 to 2015.
