**NOTES**

**Importance of signature of Past committee members.**

- The last filed (ROS) list of Governing council of the Samithi was on 24-11-2007 that of the executive committee 2006-2007 and CA Audited Account statements are of that ended 31<sup>st</sup> March 2006.
- Therefore we have to submit the signature of outgoing committee since 2007, year after year. It is requested that past executive committee members sign the relevant papers to be put before You on the date of the meeting on 2-2-2014.
- The signature of past committee members will make them **indemnified** from any legal problem arising out of errors and omissions of the President/Secretary of subsequent committees.

**Rule u/s 9 of our bye-laws**

- Any vacancy in the Executive committee which may arise due to death, resignation or any other reason shall be filled in by the members of the Executive committee from amongst themselves and by cooption of members.

**Need for election of President**

- The President, being a custodian has failed miserably to protect the Rules and regulations and not able to guide the secretary with respect to ROS obligations.
- All of the present committee members are of the opinion that conducting Mandala puja is the sole aim and not the ROS obligations. One has to remember that the Mandala puja can be **conducted by volunteers or event managers** paid or otherwise, but the ROS obligations can not be pursued without elected president/Secretary.

- Getting signature of president has been very difficult on papers for ROS in time. The accessibility of the president over phone etc is also very difficult. For example in the case of 'Muthamizh Sangam', ROS had given last date of presentation of reply was on 24-12-2013 and the signature on some important document from president could be obtained only on 11-1-2014 well beyond two weeks of the required date.
- In all replies to the notice sent by ROS since 24-10-2011 to the president and secretary, that too after two years of dead line, only vice president has signed and despatched replies. Why we need such dummy/mukut prez.
- If the services of Acharya Shri S.G. Swaminathan is indispensable as he has been the head priest for over 25 years in total with the exception of one year in between in the year 2011 when the Mandala puja was sponsored at Lord Ayyappa temple, let him be given a very honourable position of Vice president cum chairman of Puja committee, to conduct Mandala Puja.

### **Need for election of Secretary**

- The secretary since 2007 has not maintained proper minutes book which has to be presented to ROS. There is no continuity.
- The present secretary has not heeded to my request and suggestions even after taking him twice to concerned ROS staff who was overseeing our records to do what is the right procedure to get the renewal done. Instead he had gone to one 'Joshi Consultants' and asking me to make some unwanted affidavit as complainant which ultimately the ROS turned down.
- Also there is lot of anomaly, no proper continuity in accounts since 2006, false list of governing council etc without applying the mind on the papers prepared so far.
- His knowledge of Registration of Society Act as applicable to UP and our bye laws are also questionable, Even though this is not a must for secretary as one can always take the advice of legal experts, but it is desired.
- He has not heeded to my request of issue/start notice for calling a meeting on 2-2-14 was also not initiated, leading to this harsh step to issue of this notice by me as joint secretary.

### **Invitation**

- Any body in the Governing council, who has got necessary fire in belly towards the renewal of registration may come forward to take up the prez and Secretary respectively.
- The succeeding secretary also shall come prepared with necessary points for affidavit to be made by President/Secretary, after consulting ROS or any other advocate dealing with renewal of registration.
- The samithi is at present an unregistered one by the default of non filing of papers. It is a crime to utilize the funds of Registered Society and also getting public donation in the name of the samithi.

### **Request**

- As the secretary/president not having the minutes book of 2006 onwards and not having valid list of Governing council, Mr. N K omna kuttan, our regular printer or anybody else having mandala puja notices 2007,2008,2009,2010 to forward a copy (or photocopy) of the same to Dr B Sekar, the vice President.
- Also if treasurer or anybody got statement of accounts for the year ended on 31<sup>st</sup> March 2007 and for the year ended on 31<sup>st</sup> March 2008 may give the photocopy of the same to the Vice President, Dr. B. Sekar.

### **Warning**

- If this proposed executive committee meeting on 2-2-2014 goes without quorum or going in any undesired way without proper direction as per Registration of Societies Act, applicable to U.P. or not as per Rules and regulations, It is warned that Mr B N Venkataraman will take the issue further to its logical end of the errors and omissions on the part of the President/Secretary namely, Shri R C Pillai, Shri P.Venugopal, Shri S G Swaminathan, Shri K R Ganapathi and Shri V V Subramaniam and of course the treasurers Shri KDN Sharma, and Shri G Kesoram amounting to the **embezzlement** of funds of the Samithi. The team of 2010-11 had already been indicted by the then internal auditor.
- I am really feeling sorry for bringing in names, but it is inevitable to this context.

### **The secretaryship declined earlier.**

- In AGM of 13-10-2013, someone proposed me as Secretary, I simply declined on following two reasons
  - I am taking up a month long pilgrimage to Sabarimala, the Hill abode of Lord Ayyappa, during this mandalam for which I had already booked virtual Q booking for Sabarimala darshan on 3-10-2013 and my railway ticket on 11-10-2013 itself. Therefore I would be unavailable for the important only annual event of Mandala Puja of the Samithi.
  - Secondly, being an expelled member, during the previous 9 years, I am out of touch with the affairs of the Samithi for a decade.
- Now I am ready.

### **Post Script**

- It is brought to the notice of all that the complaint to ROS dated 24-10-2011/31-11-2011 ~~was~~ is being disposed off as per the withdrawal of the complainant and not by the merit of reply of the Vice President.
- **For the attention of Dr. B Sekar, Secretary, Muthamizh Sangam**

It is requested to give the venue of Tamil Sangam House on the said date and time for the conduct of the said meeting. If the hall is booked for some other function, pl give us the rear room or underground room as the terrace is not suitable for winter evening program.

Even if the venue becomes unavailable due to some other reason in the last minute, for a small gathering of around 12 persons, alternate arrangement will be done in the vicinity of the said venue. So I humbly request all invitees to be present at least 15 minutes before the scheduled time.

**Any other matter for discussion with the permission of chair**

- Post/courier in the absence of UPC has become very expensive and the Samithi can not afford as the membership fee is still 100/- for life member. How many intimation can be given with this amount for life has become a question.
- The quorum for AGM is 20 (or 1/3rd of members whichever is less) and the AGMs are being conducted with less than dozen members, not even sufficient for forming the full fledged committee as per our bye laws.
- In view of the above following measures are to be taken in committee meetings after due deliberation followed by approval in AGM.
  1. To make email-id compulsory and communications to be done by emails only. (Until going in for samithis own web site, to go under personal emails from President/Secretary)
  2. To increase the subscription fee
  3. To eliminate life membership category. Existing life members to be converted a term membership of three years or so.
  4. Upgrade your skill (gmail users) to share the google+ and take part in discussions by commenting on the google plus document/pictures or editing if permitted by uploader. For facebook users, it is a breeze for sharing docs. Face book is a public site, do not use it. Go for google+ and share privately.

- At the scheduled time of meeting, The President telephoned that he is on the way and asked us to start the meeting asking Vice President to take the chair. He was held up in traffic jam and could not arrive till the end of the meeting at 6:30 pm.
- The Vice President also left on some urgent mission at the start of the meeting leaving behind the written message of his discussion with Secretary and joint Secretary. Subsequently ..... chaired the meeting.
- Dr Sekar had indicated that the buget for bhajana party and cook is Rs. 25000. The committee okeyed it.

- Detailed budget was not on monetary value but by number of persons gathering expected, menu, number of times tea etc, for Mandala Puja. The same was estimated in detail and the secretary had them listed.
- The gathering expected for mandala Puja was 100 to 150 persons.

1. Let the secretary be equipped with following statutory documents. Make sufficient number of copies as advised by staff of Registrar of societies.
  - Minutes book (if not from 1983, at least from 2006 onwards)
  - If the minutes of meeting/agm are typewritten/computer printed paste them in appropriate places in minutes book
  - blank pages in minutes book to be signed by president
  - Membership register and membership application forms signed by members. We had them in 2002 and was with the then president
  - property register along with copies of Fixed deposit receipts on hand or its verification by Auditor in his audit report
  - Cash/bank book 2006 onwards
  - Audited Balance sheet with audit report for the years ended on 31<sup>st</sup> March 2007, 2008 2009 2010 2011 2012 2013
  - List of Governing council (as per minutes book) for the years 2006 onwards
  - Annual report along with notice calling for AGM
  - Signatures of past committee members as far as possible
  - Singnature of all present committee members in list of Go
  - draft affidavit, approved by Exec committee by sec or prez to include
    - i. Secretary is conversant with the affairs of the samithi
    - ii. No dispute is pending in any court in India
    - iii. indicate AGMs held every year only filing was not done by secretary within 14 days of AGM, or reason for not holding AGM in a particular year/years
    - iv. for non availability of signature of past committee members, affidavit should include the best efforts and proof for secretary/Prez effort in obtaining their signature.
    - v. Non availability of signature of present committee members should be explained the reason in affidavit for their non availability from (AGM) 20-10-2013 till date

- vi. details of pending dispute of 24-10-2011 filed with registrar
  - vii. How the dispute sorted out, if there is compromise, then the signed compromise letter be attached with the affidavit
  - viii. If dispute disposed of by court/Registrar then the court order/Registrars order
  - ix. Mention of documents that are being attached to the application for renewal in affidavit itself
  - x. Reason from past secretaries why they have not filed documents and renewed registration and reason for dragging it to unregistered society. This has happened in the year 2010-11 and extened period of 2011-12 wherein Shri K R Ganapathy was the concerned secretary. This has happened in spite of complaint on 24-10-2011, or condoning by AGM.
2. Do as per the advice of Registrar/staff/advocate with the above material along with sufficient copies of above document
  3. In case of any non availability of satutory document explain in affidavit proper reason for the loss.
  4. If you do not know what is statutory documents ask some CA or Advocate or staff of registrar of society

I (BNV) want to mention the following at the start of the meeeting itself.

Firstly, I bring to notice of the committee that I have already apologised for bringing in names in the paragraph 'warning'. I had issued a corrigendum also on 29-1-2014 (last wednesday) and redrafted the paragraph.

Secondly some persons like Mr. Omankuttan has a feeling that I have some personal business interest like printing work for the samithi. I was in printing business sometime in 1992-2000 and history of my printing to Samithi goes like this:

- In 1994 mandala puja I printed the notice(worth about Rs. 600) free of cost. I mentioned in notice 'laser typeset and printing by courtesy B N Venkataraman'. No body understood the meaning courtesy. No body appreciated. The quality of priting was appreciated by Shri KRS and he gave me in subsequent year, the printing of his father's Satabhishekam.
- In 1995 I printed at cost but contributed 64 coconuts worth around Rs 400 (when annadanam contribution was Rs 251/-).
- In 1996 onwards upto the year 2000 I printed the notices but I was a regular Annadanam contributor and the cost of notices were around Rs. 800/- and in the year 2000 due to printing of notices one in English and one in Hindi total for Rs. 1000/-
- In the year 2001 cost of paper shot up and I sacrificed the paper and went for inferior quality of paper for a cost of printing at Rs. 700/- only.
- For all the years I printed, I have one specimen and also the statements of accounts for those years. Not only that during those years, I printed notices for Sahasranama mandali, Ganesh Utsav etc free of cost for them.
- From 2002 onwards Shri omankuttan is printing it for cost of Rs. 1000 and more, and many years he is printing in multi color at a cost of Rs. 4000/-.
- Last mandala puja notice was printed in single color and the committee knows the single color selection is at my instance. **I am not at all in printing business now.** I do not know what was NKO's cost but I could have printed for that size and paper for the

same quality at Rs. 600/- However there is an advertisement in the mandala puja notice and it is matter between advertiser and printer to have the say in cost.

- From 2002 to 2005 nobody approached me for annadanam and later years when I met RC Pillai in temple during mandalam beginning day, I used to contribute for Annadanam. I subsequent years also I paid for Annadanam whether I am expelled or not.
- The printing of Annual report in 2000 (100 copies) was done at a cost less than the cost of photocopy of typewritten pages for 70 copies itself (one copy per member). That was for the example what all to be submitted to ROS alongwith the minutes of AGM.
